### *Milkman's arrival foils robbery bid, 3 of 6 miscreants nabbed*

■ The gang of six robbers broke into the house of well-known trader Devani with intention to rob the house. Their whereabouts were traced with help of mobile phone they stole

AMILKMAN'S arrival foiled robbery attempt in a house and resulted in arrest of three accused, said Superintendent of Police Bachchan Singh at a press conference held in this office. Three more members of the gang are absconding.

According to information, six persons tried to break into the residence of one Kisan Shashikant Devani, a resident of Lakhala, Risod Road, Washim, with an intention to rob about. As soon as the Police came to know, a police team swung into action and arrested the three miscreants, while other three are still at large.

One of the three accused and the mastermind Punjaji Kisan Idhole hatched a plan of robbery along with the help of his other accomplices, to repay outstanding amount of loan against him.

The Devani family have their residence in the busy locality at the Lakhala area. Idhole hatched a plot to strike at the residence of

Devani family along with Lakhani Ishwar Paighan, Vitthal Kashiram Paighan and three others. Idhole convinced his fellow accused saying that Devani was a big trader and if they succeeded in their attempt, they can get a handsome booty, Singh informed.

So, at around 7 pm on the fateful day, the six goons bearing arms broke into the residence of the Devani family. They intimidated women members of the family and asked them for money kept in the house.

Fortunately for the family, the milkman just arrived at the house to give milk. Sensing trouble, the miscreants dacoits fled the spot laying their hands on just one mobile phone.

The prime accused in the case Punjaji Idhole is a hardened criminal. Some other offences are also registered against him. In the meantime, he had started a business of sand and had taken a loan to start his business but failed to repay the loan amount. To clear his debts, he was in desperate need of money. So he planned the robbery.

Meanwhile, on getting information, police swung into action. The stolen mobile from the house was tracked and the location of the miscreants became known. Soon the cops raided the premises and succeeded in arresting three of them, Singh informed. Hunt is on for the remaining three accused in the case.
